



## Light Trailer Loading & Towing Training Course Options

Unit Standard Course – with pre-learning and assessment.

This course entails pre learning and assessment followed by a full day of theatrical learning & practical field training.

The applicants are assessed against the unit standards and receive a 'Certificate of Assessment.'

Ideally for applicants:

- With limited experience.
- Required to obtain the specific unit standards for recognised compliance training.
- Who have not completed any compliance refresher training in more than five (5) years (recommendation).

One Day Competency Course

This course entails approximately 3-4 hours theory followed practical training covering fundamental and legal attributes for loading and towing a light simple trailer.

Applicants on this course receive a 'Certificate of Attendance.'

Ideally for applicants:

- Who have previously completed unit standard training within the last four (4) years (This prior experience may need to be verified).
- Wishing to obtain specific training that does not require unit standards.
- Tow vehicle upgrades mean operators require an introduction to unfamiliar features & latest technology to ensure their safety whilst towing a light trailer on-road.

### Indicative Course Fees:

\$1,800 excluding GST and any disbursements (if applicable)

### **Please note that the above indicative course fees:**

- Are based on vehicles being provided free of charge by the client – 1 machine per 1-3 applicants.
- Once a course is confirmed, any non-refundable disbursements will be on charged.
- Where able, other work booked will enable some travel disbursements to be equally shared.

## Course details

**Enrolment:** 3 candidates maximum

### **One day programme:**

Unit standard courses – pre learning materials are provided. They must be completed/returned for marking prior to the course delivery date.

All courses – Include a 2-4 hour theory presentation and assessment followed by practical driving covering fundamental attributes for safe loading & towing and a light simple trailer on-road.

### **Location of training:**

Theory & practical – will take place at your workplace in a designated room suitable to deliver a presentation and complete assessment.

### **Unit Standards included: (if applicable)**

**14516** – DKO legal requirements for loading a towing a light simple trailer.

**13471** – Tow a light simple trailer.

### **Practical work includes:**

- Pre-use trailer and tow vehicle checks
- Familiarisation of unbraked/braked trailers (client specific)
- Familiarisation of trailer types - single/tandem axles (client specific)
- Loading a trailer
- Restraining a load
- Backing a vehicle/trailer combination
- Towing a light trailer on a public road

### **Entry Requirements:**

- **1For unit standard 4371** candidates must hold a minimum of the class of licence required for the vehicle being driven and comply with the requirements of the Land Transport (Driver Licensing) Rule 1999 and the Land Transport (Driver Licensing) Amendment Rule 2006.
- Loaded vehicle and trailer (GCM) must not exceed 6000KG.
- The trailer including its load (GVM) must not exceed 3500KG.

### **Post Course Support:**

On completion of training, we will provide a post course report to support your training records.
